

# Privacy Statement

## Privacy statement for ECB Sports & Cultural Club

### What is our legal framework?

All personal data are processed in accordance with **Regulation (EU) 2016/679 ('GDPR')**

### Why do we process personal data?

Personal data are processed to ensure the ECB Sports & Cultural Club (SCC) keeps the necessary information to manage memberships effectively. This means that the system only keeps data conducive to ensure effective communication with members and the right membership status.

### What is the legal basis for processing your personal data?

Your personal data are being processed by the ECB Sports & Cultural Club:

- because you consent to the processing by providing the personal data requested. You can withdraw your consent at any time by cancelling your membership in the SCC system (<https://ecbscc-site.e-captain.nl>). All processing of your personal information will stop once you have withdrawn your consent, but any prior processing will remain lawful.

### Who is responsible for processing your personal data?

The ECB Sports & Cultural Club is the controller for the processing of the personal data. The SCC Executive Committee is responsible for the processing.

### Who will receive your personal data?

The recipients of the data are members of the ECB Sports & Cultural Club Executive Committee and the Staff Info Point. The latter supports the Executive Committee in the review and approval of new membership requests.

### What type of personal data are collected through the SCC system

The ECB Sports & Cultural Club processes the following personal data:

- Name
- Staff ID (when applicable)
- Contact details (e-mail and phone number)
- Contract type / Relationship to member (for spouse/recognised partners and children) / Organisation (for non-ECB eligible members, e.g. EIOPA and ESA staff)

Data are provided by the member at the time of registration and maintained by the member (or their associate member in the case of children) manually, or monthly after a reconciliation exercise against an HR list. The SCC is not liable for any inaccuracies in data provided by the member.

## How long will the ECB Sports & Cultural Club keep personal data?

The personal data are stored while you are a member of the Club. Once you cancel your membership, your data will be deleted as will any data related to associate members, i.e. spouse/partner and dependent children.

## What are your rights?

You have the right to access your personal data and correct any data that is inaccurate or incomplete. You also have (with some limitations) the right to delete your personal data, to object or to restrict the processing of your personal data in line with **Regulation (EU) 2016/679 ('GDPR')**

## Who can you contact in case of queries or requests?
